This Notice is required by Section 247.9 of Title 6 of the Official Compilation of Codes, Rules, and Regulations of the State of New York (6 NYCRR Section 247.9). This Notice must be signed and dated by the buyer (or lessee) and the seller (or lessor) of any new outdoor wood boiler sold or leased in New York State and must be submitted to NYSDEC within seven (7) days after the new outdoor wood boiler is delivered to the buyer (or lessee).

Notice of Potential to Cause a Nuisance Condition

Even if the requirements of Part 247 are met, there may be conditions or locations in which the use of a new outdoor wood boiler unreasonably interferes with another person's use or enjoyment of property or even damages human health. If such a situation occurs, the owner or lessee of the new outdoor wood boiler causing the situation may be subject to sanctions that can include a requirement to remove the device at their own expense as well as any other penalty allowed by law.
