Pursuant to Section 9-0505 of the Environmental Conservation Law, sealed bids for the following forest products located on **Chenango Reforestation Area #2 (Beaver Meadow State Forest), Stand(s) A-27, 28, 30.1 and 30.3** will be accepted at the NYS Department of Environmental Conservation, Bureau of Procurement and Expenditures, 625 Broadway, 10th Floor, Albany, New York 12233-5025, until **11:00 a.m., Thursday, May 9, 2024.**

*These forest products are being sold from lands which have been third-party certified as being managed using responsible forestry practices and having met the requirements for Forest Certification according to the policies and principles of the Forest Stewardship Council® (FSC®) and the Sustainable Forestry Initiative® (SFI®). The stumpage advertised above may be considered **FSC 100%** under certificate number **BV-FM/COC-002027 (FSC-C002027)**, and **SFI 100% Certified Forest Content** under certificate number **6L741BVC-SFIFM-017898**. In the event the harvest site is selected for auditing while this contract is in effect, the Contractor may be required to meet with the DEC and/or Forest Certification auditors on site during the term of this contract. If required, the Contractor shall be notified a minimum of five (5) business days in advance.*

IMPORTANT SALE NOTES

This is a summary of special terms and requirements of the sale to consider when formulating your bid. Please read the entire bid prospectus for a full description of the points listed below.

- Herbicide application is required to invasive species including Morrow's honeysuckle, multiflora rose and pale swallow-wort on approximately 16 acres.
- The landings for this sale are located on an unplowed seasonal road used as a snowmobile trail.
- Prior to harvesting, the Contractor shall construct three vehicle pull-offs along the north side of New Road as shown on the sale map. This contract requires filling many large potholes along approximately 800 feet of road before harvesting.

I. LOCATION AND MINIMUM BID

This softwood/hardwood stumpage is located in the **Town of Otselic and the Town of Smyrna in Chenango County** on approximately **86 acres**. It will be sold to the highest approved bidder. Minimum acceptable bid shall not be less than **\$170,692.00 U.S.**

II. CONTRACT TERM

The Contractor will remove all material from State land and meet all the conditions of the sale contract by **October 15, 2027**. Contract extensions may be granted, at the discretion of the DEC upon written request of Contractor, when extenuating circumstances exist. No extension shall exceed 12 months in length, and the total length of all extensions shall not exceed 24 months. **In order to facilitate approval of extensions prior to contract expiration, requests for extensions, along with all other required documentation, shall be made in writing at least 60 days prior to Contract termination date. Extension requests must be acknowledged on an acceptable form provided by the DEC. To request an acknowledgment form, please contact your local DEC office or visit the DEC public web site http://www.dec.ny.gov/docs/lands_forests_pdf/acknowledgment13.pdf.**

III. NOTIFICATIONS

The Contractor will notify the DEC no less than five (5) business days prior to Contractor's intent to commence harvesting operations and at least five (5) business days prior to starting final cleanup. The Contractor will be required to meet with the DEC prior to commencing these operations. Exception to these requirements may be made only by the DEC.

It will be the Contractor's responsibility to provide the workers actually performing the work with a copy of the NOTICE OF SALE OF FOREST PRODUCTS before work begins. The Contractor shall keep a copy of the NOTICE OF SALE OF FOREST PRODUCTS on site at all times while conducting work under the terms of this Contract.

Upon determination by the DEC that any of the terms in this contract are not being upheld, the Contractor may receive a Notice to Correct by certified mail, return receipt requested. If the required work is not completed within seven (7) calendar days following receipt of such Notice to Correct, unless a good faith effort to do so is demonstrated to the DEC's satisfaction, this contract may be terminated for cause, at the discretion of the DEC.

When active work in the sale area has stopped for 14 or more consecutive calendar days or upon the completion of a stand, payment area, or other portion of the work required in the Notice of Sale, the DEC may determine that work is needed to properly close and stabilize the job site. This may include leveling access trails and/or landing areas,

installing best management practices (BMPs) including waterbars, earth berms, or other measures as required in the Notice of Sale. Upon determination by the DEC that such work is necessary, the Contractor will receive a Notice to Correct by certified mail, return receipt requested. If the required work is not completed within seven (7) calendar days following receipt of such Notice to Correct, unless a good faith effort to do so is demonstrated to the DEC's satisfaction, the contract may be terminated for cause, at the DEC's option.

This contract may be terminated or suspended by the DEC if the Contractor abandons the work under this contract; is in violation of any conditions of this contract and permit; fails or refuses to conform with the requirements of this contract; or if at any time the DEC is of the opinion that the Contractor is willfully violating any of the conditions of the contract or executing same in bad faith; or that, the Contractor has failed to promote work in a diligent manner. Upon such default or termination, the DEC shall have the right to proceed to enforce the bond posted by the Contractor in connection with this contract.

A. Firewood Notice

Rules have been implemented regarding firewood transportation into and within New York State. **Effective immediately, the transportation of untreated firewood within New York State for commercial sale is limited to 50 miles or less from the source, as defined in the regulations.** These regulations have been implemented to help prevent the spread of forest insect pests. Notice to bidders: If you are the end user of firewood you may required to remit sales tax, per the New York State Department of Taxation and Finance (https://www.tax.ny.gov/pubs_and_bulls/tg_bulletins/st/sales_tax_rate_publications.htm) . The table below lists the jurisdictions that impose a local tax on residential sales of wood for heating, and the applicable tax rate.

IV. VOLUME ESTIMATION

The volume in the standing trees was estimated and is based on the International ¼" Kerf Log Rule for sawtimber and the standard 4' x 4' x 8' cord for cordwood. Firewood volume was determined by a 10% tree sample using the US Forest Service Composite Cordwood Volume Table. Softwood volume estimates are based on a 100% tree count and a 10% volume estimate using the International 1/4" Log Rule volume tables and the U.S. Forest Service Composite Cordwood Volume Table. Hardwood sawtimber volume estimates are based on a 100% tree sample.

Additionally, volume deductions were made for visible defects; however, the DEC does not guarantee the estimated tree count, volume or quality of the stumpage advertised.

V. MARKING

Stands A-27 and A-30.1 are overstory removal of red pine to release hardwood saplings. Most, but not all, red pine are designated for harvest. Only those red pine trees marked with Blue paint shall be cut.

The trees for sale are marked with Blue paint at breast height (dbh) and on the stump. Hardwood trees tallied for saw timber are marked with a horizontal stripe (—). Merchantable softwoods and hardwood trees tallied for firewood are marked with a diagonal slash (/). Trees within skid trails are marked with double diagonal stripes (\\) in Blue paint.

Trees marked with "B" are Bump trees to remain standing until skidding is completed in that section.

The Contractor shall fell to the ground all trees so marked, including 306 cull trees marked with an "X"

Girdling cull trees or any other live trees as an alternative to felling will **not** be permitted.

The sale boundaries are shown on the attached Sale Map. Trees on the sale boundary are marked with Blue painted three stripes (≡) as shown on the sale map. All boundary trees so marked must be left uncut and are not included in this sale. In addition, the

Contractor shall not cross the three striped sale boundary with any equipment. The remaining sale area boundaries are delineated by either a State Forest property boundary, stream, road or forest type transition as indicated on attached sale maps. Trees located on State Forest property boundaries may be marked with yellow paint. Yellow painted State Forest property boundary line trees shall also be left uncut.

Payment Area A is the north block of Stand A-27 located north of the stone wall. Area B consists of the area designated for herbicide application on the west side of stands A-27 and A-28. Area C is the east side of Stand A-27. Area D includes stands A-30.1 and the white pine Stand A-30.3.

Only those trees which have been marked or otherwise designated to be cut by the DEC shall be cut under the terms of this contract. All trees so marked or designated shall be cut by the Contractor and, in the event any are not cut, they nevertheless shall be paid for under the terms of this contract. Pursuant to §9-1501 and § 71-0703 (6) (b) of the ECL, should any unmarked or otherwise non-designated tree be cut, destroyed or injured, the Contractor may be liable for a penalty of \$250.00 per tree or treble damages or both.

VI. LOG LANDINGS

Both landings for this sale are located on Graham-New Road. This is a narrow, one lane road. The portion of the road in the Town of Otselic has been abandoned. The section of New Road from Reit Road to the landing for Areas A, B and C is a continuous series of deep water-filled potholes.

Required Road Work: Prior to harvesting, the potholes in Graham-New Road west of the landing for Area B shall be filled by the Contractor with compacted crushed stone and topped with Item 4 to restore a level road surface. All work shall be to the satisfaction of the DEC.

Prior to harvesting Areas A, B or C, the Contractor shall construct a vehicle parking area west of the landing area having a size of approximately 20 feet by 20 feet. This location has Blue marked pole-size ash trees. The trees will be removed and the parking area will be surfaced with #2 crushed stone.

The section of Graham-New Road between the landing for Area B and the truck turn-around in Area D may need grading to level the road surface.

Prior to harvesting in Area D, the Contractor shall clear two vehicle parking/pull-off areas west of Area D landing. These areas are covered with dense goldenrod or saplings. The sites shall be cleared. These areas shall also be surfaced with crushed stone, if determined as needed by the DEC. The size will be determined by the DEC. These pull-offs will be constructed large enough to accommodate the vehicle parking of Contractors and DEC and also to allow another vehicle to pull off the road while allowing log trucks to pass.

The landing for Areas A, B, C is existing. The old landing for Area D is covered with yellow birch saplings and will need to be cleared for use. The truck turn-around east of the landing for Area D is existing. Any hardening of these landings or truck turn-around is the responsibility of the Contractor.

Throughout the contract term, Graham-New Road shall be maintained in an open condition passable for vehicle traffic as it is used to access private lands south of the sale area. The road shall not be blocked, except during the temporary loading of logs or equipment when the Contractor is on-site.

The Contractor may change the location of landings only with approval from the DEC.

All brush, tree tops or other debris removed for landing construction will be deposited at sites approved by the DEC.

All landing, road surfacing and parking area construction work shall be to the satisfaction of the DEC.

At the completion of the sale, the parking areas, truck turn-around and Graham-New Road shall be repaired or graded, if needed, to the satisfaction of the DEC.

Any additional site work to improve the landings to accommodate the specific needs of the Contractor will be done at the Contractor's expense and only with the approval of the DEC.

Landings will be kept in a neat condition at all times during the sale. The Contractor shall keep landings free of any garbage, oil cans, or debris. The Contractor shall remove or return to the harvest area unused wood brought to the landing from the harvest area. The Contractor shall prevent rutting on landings which may result in channelized sediment flow off the landing.

At the completion of the sale, the Contractor shall grade and stabilize the landings to the satisfaction of the DEC. If determined by the DEC that it is necessary, the Contractor shall block with earthen mounds, the entrances to skid trails leading into the woods from landing areas at the completion of the sale to the satisfaction of the DEC.

The Contractor shall prevent conditions on the landing which may result in channelized sediment flow off the landing. The Contractor shall take measures to ensure that no water or mud shall flow from the log landing into the road ditches or onto the road.

The Contractor shall not pile or process logs within the travelled way of the road as defined as the road area between the ditch lines. The Contractor shall maintain road ditches so that they are unobstructed from logs or logging debris.

Loading of trucks may be done in the road. Branches or other debris from log loading shall be regularly removed from the road surface to the satisfaction of the DEC.

The Contractor shall ensure that the road remains open and safe for public travel at all times. Trucks parked in the road may not be left unattended and must be moved, if necessary, to allow other traffic to pass.

Motorized logging equipment with steel tracks or chains are not allowed on the town roads except when loading or unloading equipment from a trailer. The Contractor is responsible for repairing any damage to DEC or town roads caused by such equipment.

Graham-New Road is not plowed in the winter and is used as a snowmobile trail. If the Contractor chooses to plow this road, the off-road parking areas shall also be plowed open and the Contractor must allow the passage of snowmobiles on the road.

Use of town roads to access the sale may be restricted due to signage limiting seasonal use and/or truck weight. Contact the Town Highway Superintendent for further information.

VII. ACCESS SYSTEM

The main logging trails have been located on the ground and on the attached map by the DEC. Trees within all main skid trails are marked with double diagonal slashes of Blue paint and/or Blue ribbons. No additions or changes to skid trail locations will be made without approval of the DEC. The Contractor shall cut and open main skid trails first before beginning harvesting within the sale area.

Individual hitches shall be no wider than the skidder.

Stream Crossings

The Contractor shall install a temporary culvert with log corduroy or bridge panels in the stream crossing in Area D. The temporary culvert will have minimum dimensions of 16 inches diameter by 20 feet long. Installation and removal of culverts, log corduroy or bridge panels shall be performed to the satisfaction of the DEC.

The Contractor may substitute temporary timber mats for log corduroy with approval from the DEC.

Installation and removal of the bridge, culverts, timber mats and log corduroy shall be performed to the satisfaction of the DEC.

The Contractor shall secure all roads, trails and landings to restrict erosion at all times to the satisfaction of the DEC according to guidelines in the publication New York State Forestry Best Management Practices for Water Quality – BMP Field Guide (BMP Field Guide). The BMP Field Guide may be viewed on-line by going to: <http://www.dec.ny.gov/lands/37845.html>. The DEC reserves the right to require the Contractor to implement erosion and sedimentation controls at any time, which includes, but is not limited to, water bars, broad based dips, corduroy, culverts, temporary bridges, straw bales, seeding and mulching.

If soil erosion occurs during harvesting, the Contractor shall install and maintain water bars, broad based dips or other appropriate water control devices at locations determined by the DEC.

The Contractor shall prevent ruts greater than 18 inches in depth on the access system during active timber harvesting. If ruts approach 18 inches in depth the Contractor shall cease harvesting activities in that area and ameliorate the damaged road or trail. The Contractor shall resume harvesting activities only when conditions improve or actions are taken to prevent further rutting. The DEC reserves the right to modify this condition on a case-by-case basis. The Contractor shall level all ruts and secure haul roads to restrict erosion at the completion of the sale to the satisfaction of the DEC.

The Contractor shall prevent ruts on all roads and logging trails that may result in channelized sediment flow.

VIII. HARVESTING

The Contractor is expected to employ directional felling techniques to minimize damage to the remaining stand. The Contractor shall also immediately pull back any tree tops falling within 25 feet of Graham-New Road.

The Contractor shall fell trees away from private land, designated recreation trails, and water courses whenever possible. If trees accidentally fall over private property boundary lines, across designated recreation trails or into stream channels, the Contractor shall pull back all material immediately.

No harvesting operations in conjunction with this sale shall be allowed on adjacent private lands without permission of the owner. The Contractor shall remove immediately any logging debris falling on adjacent private lands. Any damage to adjacent private lands shall be promptly repaired or compensation paid to the owner at expense of Contractor.

The Contractor shall keep the sale area free of litter including cans, papers and equipment parts at all times.

Active timber harvesting operations and new start-ups will be evaluated through October to determine if skidding and/or forwarding may begin or continue into the early winter season (November 1st to December 31st). Forwarding or skidding will generally not be allowed during November and December unless site conditions are favorable for the continuation of harvesting operations due to good drainage patterns or persistent freezing conditions. Exceptions may be granted by the DEC based upon specific site conditions.

Harvesting operations will be suspended during the month of April and between November 1st and December 15th due to the likelihood of wet conditions. This restriction may be altered by DEC depending on weather conditions. Exceptions must be approved by the DEC. DEC may partially or wholly restrict harvesting operations during periods of wet and/or muddy conditions throughout the contract period.

The Contractor shall only cross stone walls where designated by the DEC. The Contractor shall fell trees away from stone walls whenever possible. The Contractor shall remove any tree tops falling on the stone wall without damaging the stone wall and shall repair damage to stone walls other than at designated crossings.

Harvesting shall begin in the back of the sale area with work progressing toward the front, cutting all designated trees as the job progresses. Exceptions must be approved by the DEC.

Harvesting may begin in any Area provided it is in compliance with the payment schedule. Once harvesting has begun in an Area, the harvesting must be completed in that Area before beginning work in a new Area.

The Contractor shall leave stump heights, measured on the uphill side, no greater than the diameter of the stump unless otherwise directed by the DEC.

The Contractor shall not leave trees or tree tops hung up in the sale area and must pull any hung trees or tree tops down immediately.

The DEC reserves the right to restrict the size of the equipment used when, in the judgment of the DEC, said large equipment is causing unacceptable damage to the site and residual stand. The Contractor shall prevent rutting and soil compaction in the general harvest area (excluding the access system) and take the necessary measures to prevent ruts and soil compaction when ground conditions may not support harvesting equipment. Measures may include but are not limited to corduroy, restricting equipment access, utilizing floatation tires or tracks, or depositing tops in front of harvesting equipment.

The Contractor shall cut off close to the stump any saplings two inches or greater in diameter at the stump damaged as a result of timber harvesting activities.

Sale Specific Harvesting Regulations

Forwarding of logs longer than 20 feet in length is not allowed. Forwarders with eight wheels shall utilize at least one set of tracks.

Skidding is allowed.

The Contractor shall only begin harvesting in Area B upon DEC approval of completion of the herbicide application. After the herbicide is applied, there will be a waiting period of four to six weeks to allow for the full effectiveness of the herbicide to take place. **No harvesting may take place until the applicator has provided the required pesticide application record to the DEC.** Upon approval from the DEC, harvesting may begin if weather conditions permit.

Most of this sale is an over story removal with a residual stand to be composed of seedlings and saplings. The Contractor shall only harvest trees from **August 1st to October 15th** and during frozen conditions between **December 15th and March 15th**. Exceptions must be approved by the DEC.

There is no requirement to utilize the trees down to a specified diameter; however, utilization shall be to not less than a top diameter of 4 inches.

Whole tree harvesting will not be permitted. The Contractor shall limb and top all trees in the woods.

If the Contractor uses a mechanized harvester to cut the pine or spruce, the Contractor shall place tops in the path of the harvester. Forwarders may only travel in the harvester's path and on the main trails unless otherwise approved by the DEC.

The Contractor shall buck all material to length or multiples thereof in the woods.

The Contractor shall not lop hardwood tops, except as needed for harvesting.

The Contractor shall lop all softwood tops to a main stem diameter of 5 inches, so that no material greater than 2 inches in diameter extends more than 4 feet above the ground.

No more than 5% of the residual trees greater than 5 inches diameter at breast height within the harvest area may be damaged during the harvest operation, as determined by the DEC. A tree considered to be damaged may include but is not limited to:

1. Damage to the main stem of the residual tree which results in the loss of bark greater than 90 square inches.
2. Greater than 40% damage to the entire root system of the residual tree from soil compaction or disturbance within an area defined by a 20 foot radius from the tree's stem.
3. Greater than 25% damage to the live crown of the residual tree.

IX. ADDITIONAL SALE RELATED WORK

The following work shall be performed by the Contractor at its cost and expense:

Herbicide Application Plan

Description:

Herbicide application to undesirable understory vegetation is required in all of Sale Area B and in a small part of Area D, totaling +/- 16 acres in the locations as shown on the sale map. The target species for the application of herbicide are all Morrow's honeysuckle, multiflora rose and pale swallow-wort within the designated treatment areas. The target species in Area B are primarily scattered groups of honeysuckle with a much lesser amount of multiflora rose. Pale swallow-wort was present immediately west of and within 100 feet of the log landing for Area B. This area will be inspected and any surviving swallow-wort found will be treated. In Area D, the Contractor shall treat a large patch of pale swallow-wort along the east side of a small stream. This patch is approximately 200 feet x 66 feet in size. Scattered honeysuckle and multiflora rose are present in this patch and will also be treated with herbicide.

The boundaries of the herbicide application area in Area B are identified with a State boundary line on the west side, Blue three-strip sale boundary on the north, and designated main skid trails on the east side. On the south side, target species will be treated up to the road edge. The treatment area includes any target species on the log landing for Area B. In Area D, the designated treatment area is marked with Blue painted two-stripe boundary. The southwest side of this area is a small stream. The delineation of the herbicide areas shown on the map will be confirmed by the DEC forester upon meeting with the herbicide subcontractor. Herbicide application is required within the entire designated area.

Prior to spraying, the Contractor shall meet the DEC to review the herbicide application area and complete a Pesticide Application Record of Concurrence. The Pesticide Application Record of Concurrence will be filled out by the Contractor and the DEC to prescribe the specific methods of application and herbicides used for each target species, including mixing rates and application rates for each treatment. The completed Pesticide Application Record of Concurrence shall be made part of this sale and the information contained therein shall serve as the final confirmation of the herbicide products and application methods used in this treatment. However, the information provided below is the default treatment and shall be used as an indication of the scope of work intended by the DEC for the purposes of bidding. A copy of the Pesticide Application Record of Concurrence is available upon request.

Required/Recommended Herbicides & Required Timing of Application:

The target vegetation will be treated by the Contractor with the specified herbicides according to the schedule in the table below:

Comparable herbicide products using the same active ingredients as those specified above and approved for forestry use as described below may also be used. The Contractor may choose the most suitable application method, subject to DEC review and concurrence. Additional or alternative herbicides or application methods must be documented in the Pesticide Application Record of Concurrence discussed above. Any surfactants used in Area D shall be labelled for use in riparian or aquatic conditions.

Selected herbicides, methods of application, conditions and procedures set forth in this Herbicide Application Plan will cover additional treatments as necessary to effectively eliminate target species.

Safety Procedures/Personnel:

Application of herbicides must be done according to product labels (labels attached) and manufacturer's safety instructions and in compliance with State regulations. If the Contractor desires to subcontract the herbicide application, the Contractor shall act as the agent of the DEC and shall only subcontract to a registered pesticide business that is currently registered with the NYS DEC and employs a certified applicator in the appropriate category (ie: Category 2). If the Contractor desires to perform the herbicide application, then the Contractor needs to meet the same criteria as the subcontractor would. A pesticide applicator who is a holder of a N.Y.S. Commercial Applicator Permit (Category 2) must be present during the spraying operation.

Application of herbicide outside of the time periods described above is not recommended; however, the DEC may consider exceptions on a case-by-case basis. Spraying outside of the above date ranges shall not occur without prior approval of the DEC. The Contractor shall assume all risk for working outside of the above date ranges. Other modifications to this control plan shall not be made without prior approval of the DEC.

The Contractor shall not use any pesticide appearing on the “FSC® list of ‘highly hazardous’ pesticides”, available at <https://ic.fsc.org>; nor any pesticide listed on the World Health Organizations, “WHO Class 1a (extremely hazardous) and Class 1b (highly hazardous chemicals)”; nor any chemical listed by the Stockholm Convention as Persistent Organic Pollutants (POPs).

Proposed Application Method:

Prior to spraying, the Contractor shall make arrangements to meet the DEC to review the herbicide application area. The Contractor shall also notify the DEC after application is complete.

Foliar herbicide applications will be applied by the Contractor using a hand-held spray wand according to the product label and manufacturer’s safety instructions. Foliar applications shall be applied to the target vegetation uniformly throughout the area on a spray-to-wet basis but not to the point of runoff.

All of the designated area must be treated uniformly and after the herbicide application, at least 80% or more of the target vegetation stems must be dead. The effectiveness of the herbicide application will be evaluated by the DEC after June 15th during the following growing season through the use of six-foot radius sample plots. Fern and woody species will be evaluated separately for effectiveness of the herbicide application. A contract extension will be required if the herbicide evaluation time period extends beyond the term of the contract. If the goal is not obtained after the first treatment, an additional herbicide application will be required. The Contractor will be required to file an extension to the sale if there is not sufficient time remaining in the original contract to properly evaluate the effectiveness of the application and to conduct any secondary herbicide application. Failure to do so may result in the forfeiture of all or part of the performance bond.

Herbicide application shall stay 25 feet away from wetlands, spring seeps, intermittent streams and State boundary lines

Herbicide application shall stay 25 feet away from State boundary lines.

Equipment used in the application of herbicide or otherwise contaminated with herbicide shall not be used to draw water. Water mixed into herbicides will be brought to the site and will not be drawn from any water body adjacent to or located on State Forests.

Upon completion of the herbicide application, the Contractor shall immediately notify the DEC. Additionally, the Contractor shall provide a pesticide application record for each herbicide used in the treatment area which includes: the product name, EPA Registration #, target species, start and end dates, acres treated, total amount of product used, method of application, and the restricted entry interval. Forms are available upon request from Dec. No harvesting may begin until the pesticide application record is received by the DEC.

Public Notification Procedures:

The Contractor shall post a temporary warning sign at the primary entrance to the application site with the date and time of the most recent application. A sign may be provided by DEC upon request.

Weather/Treatment Conditions:

To ensure the effectiveness of foliar applications, herbicide spraying shall only take place when the foliage is dry. Herbicide spraying shall not take place when rainfall is expected within 12 hours before and after application, during times when the temperature is below 68 degrees Fahrenheit, or when winds are gusty or exceed 10 miles per hour. The herbicide spraying shall be done in a manner, such that drifted herbicide does not impact adjacent private land.

No herbicide application may take place when the Palmer Drought Index drops below negative two (-2). The Palmer Drought Index map is available on the internet at: https://www.cpc.ncep.noaa.gov/products/monitoring_and_data/drought.shtml. Scroll down to and select: Palmer Drought Severity Index Graphic (current). The DEC may allow or prohibit spraying if local conditions differ from the Palmer Drought Severity Index.

X. RARE, ENDANGERED, THREATENED OR SPECIAL CONCERN SPECIES

The DEC reserves the right to implement temporary restrictions on harvesting activities to protect previously unknown occurrences of rare, endangered, threatened or special concern species found within or near the sale area.

XI. OSHA and SAFETY RELATED TERMS

OSHA regulations relating to safety and safety equipment must be followed at all times by the Contractor.

Non-designated dead or hazardous trees may be cut, pushed or pulled down when necessary to comply with OSHA regulations, but must be left on the site next to the stump and may not be utilized by the Contractor. In this situation, when the Contractor cuts a non-designated tree, the Contractor must notify the DEC within one business day. When the Contractor identifies a hazard tree which is too dangerous to cut or work around and will impact the completion of the contract, the Contractor must notify the DEC. If the hazardous situation cannot be resolved or mitigated, the DEC (upon consultation with the Contractor) will decide on an acceptable solution.

No person under the age of 18 shall be allowed within 100 feet of the sale area during harvesting operations unless they are part of a registered apprenticeship program, or enrolled in a recognized vocational training program or an approved on-the-job training program, or have completed such a program, and be at least 16 years old. Sale area shall be defined as the area identified on the sketch map developed for this sale and shall include the area marked for harvest, roads and trails accessing it, and the log landing.

XII. PERSONAL PROTECTIVE EQUIPMENT FOR CHAINSAW USERS

Any person operating a chainsaw for any purpose while undertaking the activities authorized by this contract are required to wear Personal Protective Equipment (PPE), including at least the following: hard hat, eye protection, hearing protection, and cut-resistant chaps or pants. Additionally, the chainsaw must be equipped with properly functioning safety devices, including, at minimum, a properly functioning chain brake.

XIII. LOGGER TRAINING

Any person who will perform any duties related to the felling, handling and removal of trees under this contract, hereunder referred to as "worker," regardless of whether they are an

employee or subcontractor of the Contractor, shall maintain current (non-expired) certification under a Sustainable Forestry Initiative State Implementation Committee (SFI SIC) approved training program or equivalent program which includes a continuing education component, for the duration of the timber sale contract. Examples of acceptable training programs include, but are not limited to, the following:

- New York Logger Training (NYLT)
- Pennsylvania SFI Professional Timber Harvester Training Program
- Vermont Logger Education to Advance Professionalism (LEAP)
- Massachusetts Department of Conservation and Recreation Harvester License
- Maine Certified Logging Professional Program
- New Hampshire Professional Loggers
- Maryland/Delaware Master Logger Program
- Ohio Master Logger Certification

The DEC reserves the right to evaluate additional certification, licensing or training programs to determine whether they are comparable to the minimum standards for the above-listed programs. Evaluation and final determination for such programs shall be conducted by the Chief of Bureau of Forest Resource Management (BFRM) or the BFRM's State Forests Section Leader.

Prior to starting any timber sale tasks related to the felling, handling and removal of trees, the Contractor shall provide to the DEC a list of all worker names and certification or license numbers (TLC number or equivalent) or a copy of the worker's logger training certificate (TLC certificate or equivalent) of any worker who will perform any duties related to the felling, handling and removal of trees.

If a worker's certification, licensing, or training expires during the contract period, that worker shall not perform any timber sale tasks related to the felling, handling and removal of trees until proof of current certification, licensing or training is provided to the DEC.

Duties related to the felling, handling and removal of trees shall include but are not limited to the use of chainsaws, mechanized felling and harvesting equipment, skidding and forwarding, slashing, chipping and stacking of forest products, or any other method of felling, handling or removing trees.

Workers who are not certified by an SFI SIC approved training program (or equivalent) may perform duties related to the felling, handling and removal of trees as long as the Contractor, in good faith, assures the DEC that the non-certified worker is actively pursuing certification by an SFI SIC approved training program (or equivalent). A contractor certified by an SFI SIC approved training program (or equivalent) may only supervise one non-certified worker (1:1 ratio) at any given period during the life of this contract. The Contractor shall inform the DEC when the worker receives certification by an SFI SIC approved training program (or equivalent) and provide proof of certification upon request.

Truck drivers and loader operators are not required to be certified if their only duties are the loading of forest products onto the truck and/or transportation of forest products from the harvesting site.

XIV. FLUID LEAK CONTROL

The Contractor will be responsible for the control and collection of fluids leaking from any equipment used on the site. The Contractor must have a spill containment and cleanup kit appropriate for the equipment being used. At a minimum, the kit will contain: plugs and clamps to control hydraulic line breaks, a container to collect leaking fluids, fluid absorbent pads and a shovel. Operating any equipment noticeably leaking fluids is prohibited. The Contractor must take action to collect and control fluids leaking from inactive equipment or equipment being maintained or repaired on-site. The collected fluids must then be reused or properly disposed of. For additional information regarding the handling of hazardous materials please refer to page 28-29 of the New York State Forestry BMP Field Guide – 2018 Edition.

For more information please reference the DEC Spills webpage <https://www.dec.ny.gov/chemical/8692.html> and the Spills Hotline number 1-800-457-7362. All petroleum spills that occur within New York State (NYS) must be reported to the Spills Hotline within 2 hours of discovery, except spills which meet **all of the following criteria:**

1. The quantity is known to be less than 5 gallons; **and**
2. The spill is contained and under the control of the spiller; **and**
3. The spill has not and will not reach the State's water or any land; **and**
4. The spill is cleaned up with 2 hours of discovery

XV. DIESEL EMISSIONS REDUCTION ACT 2006

In 2007, New York State passed legislation establishing the Diesel Emissions Reduction Act 2006 (DERA.) This Act amended the Environmental Conservation Law (ECL) by adding Section 19-0323 which requires the use of best available retrofit technology (BART) and ultra low sulfur diesel fuel (ULSD) for heavy duty vehicles owned or operated by, including on behalf of, state agencies and state or regional public authorities. The Department has promulgated regulations (6 NYCRR Part 248) to provide guidance on provisions of the law. The regulations may be found on the Department's website at <http://www.dec.ny.gov/regs/2492.html>.

The successful bidder must comply with the specifications and provisions of ECL Section 19-0323 and NYCRR Part 248, which require the use of BART and ULSD, unless specifically waived by the Department. Qualifications for a waiver under this law are the responsibility of the successful bidder.

XVI. SEXUAL HARASSMENT PREVENTION CERTIFICATION

State Finance Law §139-l requires bidders on state procurements to certify that they have a written policy addressing sexual harassment prevention in the workplace and provide annual sexual harassment training (that meets the minimum requirements of section two hundred one-g of the NYS Labor Law and Department of Labor's model policy and training standards) to all its employees.

Where competitive bidding is required pursuant to statute, rule or regulation, every bid made to the state or any public department or agency of the state must contain the following statement:

"By submission of this bid, each bidder and each person signing on behalf of any bidder certifies, and in the case of a joint bid each party thereto certifies as to its own organization, under penalty of perjury, that the bidder has and has implemented a written policy

addressing sexual harassment prevention in the workplace and provides annual sexual harassment prevention training to all of its employees. Such policy shall, at a minimum, meet the requirements of section two hundred one-g of the labor law.”

Bids that do not contain the certification will not be considered for award; provided however, that if the bidder cannot make the certification, the bidder shall provide a signed statement with their bid detailing the reasons why the certification cannot be made. After review and consideration of such statement, the DEC may reject the bid or may decide that there are sufficient reasons to accept the bid without such certification.

Bidders are required to sign and submit the attached Sexual Harassment Prevention Certification form. If the bidder cannot make the certification, then a signed statement must be submitted with the bid detailing the reasons why the certification cannot be made.

XVII: EXECUTIVE ORDER No. 16

Executive Order No. 16 provides that “all Affected State Entities are directed to refrain from entering into any new contract or renewing any existing contract with an entity conducting business operations in Russia.” The complete text of Executive Order No. 16 can be found at <https://www.governor.ny.gov/executive-order/no-16-prohibiting-state-agencies-and-authorities-contracting-businesses-conducting> . The Executive Order remains in effect while sanctions against Russia imposed by the federal government are in effect. Accordingly, vendors who may be excluded from award because of current business operations in Russia are nevertheless encouraged to respond to solicitations to preserve their contracting opportunities in case the sanctions are lifted during a solicitation or even after award in the case of some solicitations. As defined in Executive Order No. 16, an “entity conducting business operations in Russia” means an institution or company, wherever located, conducting any commercial activity in Russia or transacting business with the Russian Government or with commercial entities headquartered in Russia or with their principal place of business in Russia in the form of contracting, sales, purchasing, investment, or any business partnership. Vendors responding to this solicitation are required to complete and submit the form entitled “Certification Under Executive Order No. 16 Prohibiting State Agencies and Authorities from Contracting with Businesses Conducting Business in Russia”.

XVIII. TERMS OF BIDDING

Bids must be submitted via mail, delivery service, or in person. All bids must be submitted on the original *Bid Proposal* (Proposal) form supplied by the DEC for this specific sale and included with this Notice. Alternate forms of bidding, including photocopies, will not be accepted. All blanks on the Proposal form must be completely filled in. Amounts must be written out and also stated in figures. Alteration of the Proposal by which the terms are changed may cause rejection of the bid. *Please note that the bid deadline is for receipt of the bid at the address listed below, not for mailing or entrusting to a delivery service. The*

Department is not responsible for lost or late mailings. Late bids will be returned unopened. No electronic submissions will be accepted.

The original Bid Proposal must be accompanied with a completed and signed original Bidders/Proposers Certification form, Executive Order No. 16 Certification, and Sexual Harassment Prevention Certification form. The original Bid Proposal, Bidders/Proposers Certification form, Executive Order No. 16 Certification, Sexual Harassment Prevention Certification, and bid deposit for this sale must be submitted in an envelope addressed to "NYS DEC, Bureau of Procurements & Expenditures, 625 Broadway, 10th Floor, Albany, NY 12233-5025," and clearly showing only the following information:

XIX. TERMS OF SALE

A. General

All monetary references are in U.S. dollars. All material will be paid for by the Contractor prior to the commencement of harvesting operations. The Contractor will execute and return the sales contract to “NYS DEC, Attn: State Timber Sales, 625 Broadway, 5th Floor, Albany, NY 12233-4255,” along with all other required documentation, within 30 calendar days of Notice of Award.

The successful bidder will not commence operations hereunder until payment according to the payment schedule is made, and a fully executed copy of the sales contract is received by him/her with authorization to proceed with removal of products.

The Contractor may subcontract for the performance of work pursuant to this Contract only with the prior written approval of the DEC. If the Contractor enters into subcontracts for the performance of work pursuant to this Contract, the Contractor remains liable for compliance with all the terms of this Contract. The Contractor shall take full responsibility for the acts and omissions of its subcontractors.

B. Vendor Responsibility

State procurement laws require that state agencies award contracts only to responsible Contractors. To fulfill this requirement, potential Contractors may be required to complete a Vendor Responsibility Questionnaire or otherwise provide additional information to assist the DEC in assessing responsibility.

- **General Responsibility:** The Contractor shall at all times during the Contract term remain responsible. The Contractor agrees, if requested by the Commissioner or his or her designee, to present evidence of its continuing legal authority to do business in New York State, integrity, experience, ability, prior performance, and organizational and financial capacity.
- **Suspension of Work (for Non-Responsibility):** The Commissioner or his or her designee, in his or her sole discretion, reserves the right to suspend any or all activities under this Contract, at any time, when he or she discovers information that calls into question the responsibility of the Contractor. In the event of such suspension, the Contractor will be given written notice outlining the particulars of such suspension. Upon issuance of such notice, the Contractor must comply with the terms of the suspension order. Contract activity may resume at such time as the Commissioner or his or her designee issues a written notice authorizing a resumption of performance under the Contract.
- **Termination for Non-Responsibility:** Upon written notice to the Contractor, and a reasonable opportunity to be heard with appropriate DEC officials or staff, the Contract may be terminated by the Commissioner or his or her designee at the Contractor’s expense where the Contractor is determined by the Commissioner or his or her designee to be non-responsible. In such event, the Commissioner or his or her designee may complete the contractual requirements in any manner he or she may deem advisable and pursue available legal or equitable remedies for breach.

- **Vendor Responsibility Questionnaire:** The DEC recommends that vendors file a required Vendor Responsibility Questionnaire online via the New York State VendRep System. Vendors must provide their New York State Identification Number when enrolling. Vendors opting to complete and submit a paper questionnaire can obtain the appropriate questionnaire from the VendRep website www.osc.state.ny.us/vendrep or may contact the Department of the Office of the State Comptroller’s Help Desk for a copy of the paper form.

C. Payment Schedule

The Contractor will make payments according to the following schedule unless adjusted by the DEC:

- 1st Payment = 10% of purchase price previously paid as bid deposit.
- 2nd Payment = 20% of purchase price prior to commencement of harvesting operations in Area A.
- 3rd Payment = 20% of purchase price prior to the commencement of harvesting operations in Area B.
- 4th Payment = 25% of purchase price prior to the commencement of harvesting operations in Area C.
- 5th Payment = 25% of purchase price prior to the commencement of harvesting operations in Area D.

Regardless of harvesting activity completed or commenced, the Contractor shall make payments in the amount of **50%** of the purchase price before **August 15, 2026**, and shall make payments in the amount of **100%** of the purchase price before **January 15, 2027**.

No payment other than the 10% bid deposit will be accepted until the Comptroller has approved the sales contract. Failure to execute and return the sales Contract to the *NYS DEC, Attn: State Timber Sales, 625 Broadway, 5th Floor, Albany, NY 12233-4255*, along with all other required documentation, within 30 calendar days of Notice of Award may result in forfeiture of the bid deposit and the awarding of this sale to the next highest bidder. Payments shall be in the form of check or money order made payable to the “**NYS Department of Environmental Conservation**” and submitted to *NYS DEC, Attn: State Timber Sales, 625 Broadway, 5th Floor, Albany, NY 12233-4255* before the date stipulated in the Payment Schedule.

D. Performance Bond

The executed contract must be accompanied by one of the following:

- a Surety bond
- a Bank/Certified check
- a Certificate of Deposit assigned to the Department of Environmental Conservation
- a Letter of Credit from a Federally chartered or State licensed financial institution

in the amount of **\$7,500.00** for the faithful performance of the sales contract.

E. Notarizations

The following rules apply for any individual designated as "**Notary**" on all Department contracts:

- Any stockholder, director, officer, or employee of a corporation that is a party to the contract either as an individual OR as representative of the corporation may not take an acknowledgment /notarize.
- If the employee has an ownership interest in the company and a DIRECT monetary interest in the contract (their pay depends upon it and it alone) they may not take the acknowledgement /notarize. **An employee with no ownership interest in the company may notarize contract signatures.**

F. Insurance

The Contractor shall be required to procure, at their sole cost and expense, and shall maintain in force at all times during the term of any Contract resulting from this solicitation, policies of insurance as required herein. All insurance required herein shall be written by companies that have an A.M. Best Company rating of "A-," Class "VII" or better. In addition, companies writing insurance intended to comply with the requirements herein should be licensed or authorized by the New York State Department of Financial Services to issue insurance in the State of New York. The Department may, in its sole discretion, accept policies of insurance written by a non-authorized carrier or carriers when certificates and/or other policy documents are accompanied by a completed Excess Lines Association of New York (ELANY) affidavit or other documents demonstrating the company's strong financial rating. If, during the term of a policy, the carrier's A.M. Best rating falls below "A-," Class "VII," the insurance must be replaced, on or before the renewal date of the policy, with insurance that meets the requirements above.

The Contractor shall furnish to the DEC a certificate or certificates with the appropriate endorsements showing that it has complied with this Article. The insurance documentation shall provide that:

- Liability and protective liability insurance policies shall provide primary and non-contributory coverage to the DEC for any claims arising from the Contractor's Work under this contract, or as a result of the Contractor's activities. Insurance policies will not be accepted that:
 - remove or restrict blanket contractual liability located in the "insured contract" definition (as stated in Section V, Number 9, Item f in the ISO CGL policy) so as to limit coverage against claims that arise out of work; or
 - remove or modify the "insured contract" exception to the employer's liability exclusion; or
 - do not cover the additional insured for claims involving injury to employees of the named insured or subcontractors.
- **The State of New York, NYS Department of Environmental Conservation, its officers, agents and employees, with the address: "NYS DEC, Attn: State Timber Sales, 625 Broadway, 5th Floor, Albany,**

NY 12233-4255,” shall be listed as **Certificate Holder** on all liability insurance certificate(s), as “Additional Insureds” on endorsement(s), and on additional supporting documentation.

- In the “Description of Operation/Locations...” section, the **Contract Number and Forest (X013274, Chenango 2)** **must** be referenced.
- The policies shall include a **Waiver of Subrogation** endorsement in favor of the DEC as an additional insured. The endorsement shall be on ISO Form number CG 24 04 or a similar form with same modification to the policy.
- Policies shall not be changed or canceled until thirty (30) days prior written notice has been given to the DEC; as evidenced by an endorsement or declarations page.
- Insurance documentation shall disclose any deductible, self-insured retention, aggregate limit or any exclusion to the policy that materially changes the coverage required by the Contract.
- Endorsements in writing must be added to and made part of the insurance contract for the purpose of changing the original terms to reflect the revisions and additions as described. A copy of these endorsements must be provided to the DEC.
- Applicable insurance policy number(s) referenced on the ACORD form must be referenced in the supporting documentation requested by the DEC and supplied by the insurance company (e.g. endorsement page, declarations page, etc.).
- Worker’s Compensation and Disability Benefits certificates shall name the **New York State Department of Environmental Conservation, with the address: NYS DEC, Attn: State Timber Sales, 625 Broadway, 5th Floor, Albany, NY 12233-4255**, as entity requesting proof of coverage.
- This Contract shall be void and of no effect unless the Contractor procures the required insurance policies and maintains them until acceptance or completion of the work, whichever event is later. If at any time during the term of this contract the coverage provisions and limits of the policies required herein do not meet the provisions and limits set forth in the Contract or proof thereof is not provided to the DEC, the Contractor shall immediately cease Work on the Project. The Contractor shall not resume Work on the Project until authorized to do so by the DEC.
- Should the Contractor engage a subcontractor, the Contractor shall impose the insurance requirements of this document on the subcontractor. Contractor shall determine the required insurance types and limits, commensurate with the work of the Subcontractor. The Contractor will maintain the certificate or certificates and endorsements for all subcontractors hired as part of the Contractor’s records.

The following types and amounts of insurance are required for this Contract:

1. Workers' Compensation:

3. Commercial General Liability Insurance:

Contractor shall provide and maintain Commercial General Liability Insurance (CGL) covering the liability of the Contractor for bodily injury, property damage, and personal/advertising injury arising from all work and operations under this contract.

5. Umbrella and Excess Liability:

When the limits of the CGL, Auto, and/or Employers' Liability policies procured are insufficient to meet the limits specified, the Contractor shall procure and maintain Commercial Umbrella and/or Excess Liability policies with limits in excess of the primary; provided, however, that the total amount of insurance coverage is at least equal to the requirements set forth above. Such policies shall follow the same form as the primary.

The Contractor shall require that any subcontractors hired, carry insurance with the same limits and provisions as provided herein.

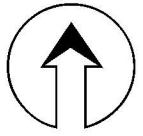

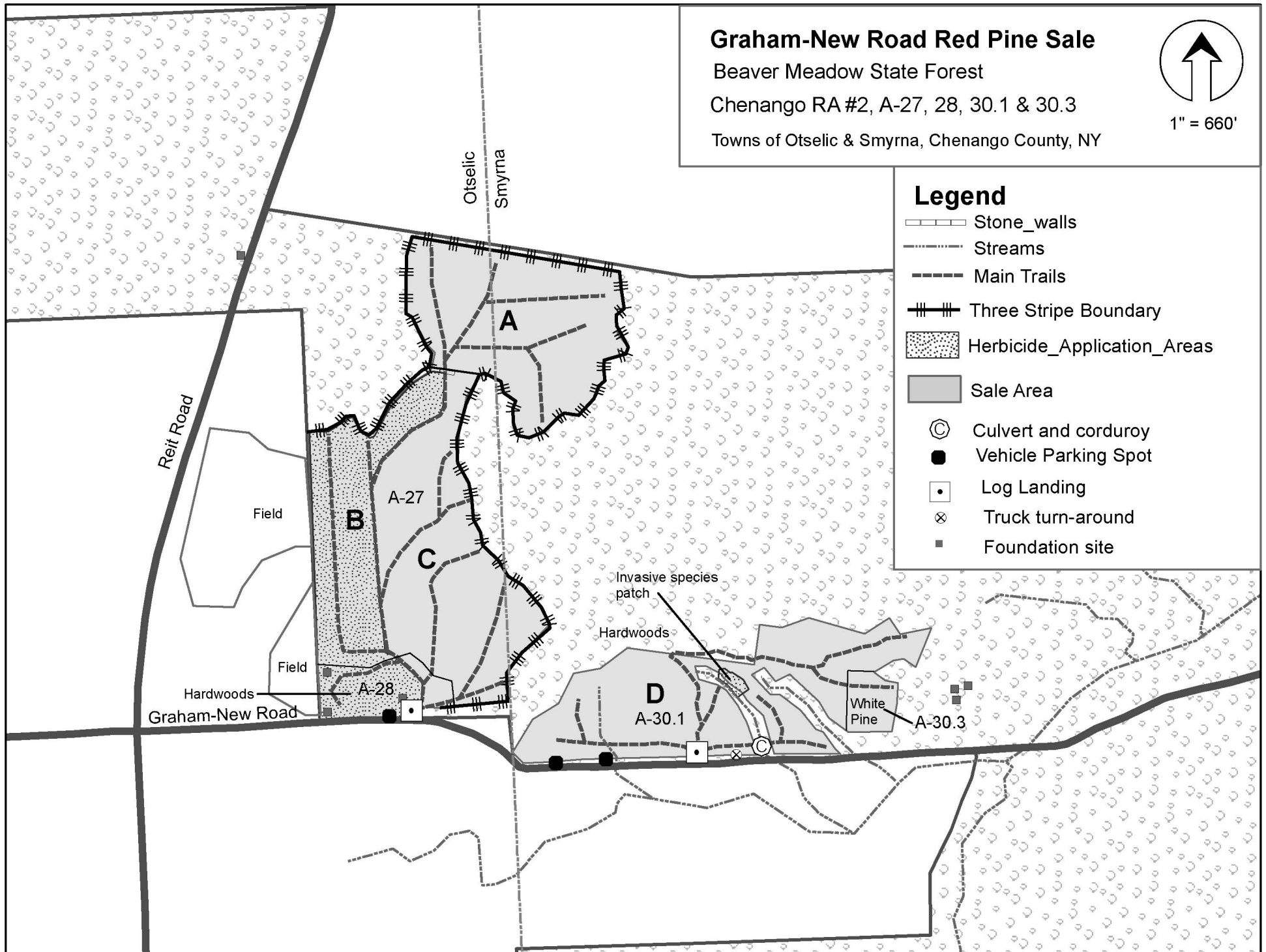
